The overall Fire District Budget is decreasing -\$91,793.62, -3.9% from 2021, primarily due to less capital projects in 2022.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Total Fund Balance Utilized is decreasing -\$304,415.22, -64.5% from less Capital Projects in 2022. Debt Service is increasing \$109,637.54, 100% Principal and Interest \$12,681.45, 100% from the acquisition of a Pumper. Commissioner Salaries increased \$2,500, 12.5% since it has been several years since the last increase. Building Maint & Repair increased \$5,000, 33.3% from additional cleaning procedures. Continuing Education increased \$5,000, 50% due to increased education for Career Staff. Supplies decreased \$5,000, 20.0% due to less need. Utilities decreased -\$10,000, -14.3% from historical data from that expense. Replacement Equipment increased \$10,000, 33.3% due to aging equipment needing upgrading. Training decreased -\$5,000, -16.7% from less training since Covid. Technology increased \$3,000, 75% due to continuing subscriptions for computers. Small Gen, Fans and Thermal Camera's decreased \$18,000, 100% from less need for those Non Bondables.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The Amount to be raised by taxation increased \$212,621.60, 11.6% primarily from debt service incurred in the 2022 Budget. Unreserved Fund Balance was utilized to offset Capital Appropriations of \$105,000 and \$62,400 to offset the 2022 Budget. The Fire District is in compliance with the Property Tax Levy Cap.
