The overall Fire District Budget is increasing \$549,488.75 (+30.7%) from 2020, primarily due to capital projects of \$340,000.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Election Expense is increasing \$10,000 (+200%) due to upcoming increased election expenses due to mail in ballots. Education increased \$10,000 (+100%) due to monies being appropriated for continuing education classes for Career staff. SCBA increased \$5,000 (+50%) due to aging equipment needing repairs. Replacement equipment increased \$10,000 (+50%) for extrication tools being updated. Training increased \$5,000 (+20%) for hands on training needed in 2021. Technology expense was broken out of Office Expense for \$4,000 (+100%) do to increased technology being used on equipment and office. Vehicle Equipment increased \$30,000 (300%) for equipment needed for the new Utility Vehicle being purchased and outdated equipment being replaced. Building Maint and Repair increased \$5,000 (50%) for Career Office updates being done in 2021. Non Bondable Equipment increased \$40,000 (+142.9%). Losap increased \$5,000 (10%) due to more volunteers qualifying for Losap. Capital Appropriations increased \$340,000 (+100%) for \$200,000 tractor, \$100,000 for Firefighting Equipment and \$40,000 for a Utility Vehicle.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The amount to be raised by taxation is increasing \$77,673.53 (+4.4%). The district is using \$471,815.22 in Unrestricted Fund Balance to offset captial appropriations and the budget. The fire district is in compliance with the Property Tax Levy Cap.
