Minutes of Meeting Held April 14, 2022

Notice of the time, date, location and agenda of this meeting to the extent then known, was duly published in the district's official newspapers, posted on its official bulletin board and filed with the office of the municipal clerk at least forty-eight hours in advance of this meeting. This meeting is being conducted in accordance with the terms and provisions of the "Open Meetings Act" of the State of New Jersey.

<u>Call to Order</u>: the meeting was called to order by Commissioner Couceiro at 6:05 pm. Board Attorney Braslow read "Open Meetings Act" statement. All participated in the Pledge of Allegiance. A moment of silence was observed.

Roll Call: Commissioners Couceiro, Jamison and Goldman were present. Commissioners O'Brien and Torres were absent. Board Attorney Braslow was also present via remote communications.

<u>Minutes</u>: Minutes from the March 10, 2022 were tabled to the May 12, 2022 meeting due to a lack of quorum (Commissioner Goldman was absent from the March 10, 2022 meeting).

<u>Treasurer's Report:</u> The bill list as well as the report (a copy of which is attached to the original minutes and incorporated herein by reference) as of April 14, 2022 was presented and left on table for public review. Commissioner Jamison read the cash balances into the record. Commissioner Goldman motioned to accept the Treasurer's report and pay the bills, seconded by Commissioner Couceiro. Motion passed by unanimous consent.

<u>Legal Report</u>: Board Attorney Braslow reported remotely that the notices and Resolutions were done. He further reported that he spoke to a DCA staff member. Upon receipt of the Performance Evaluation he will then meet with Board Attorney Braslow.

Truck & Building/Career Department Report – read by Captain Leonard (a copy of the written report is attached to the original minutes and incorporated herein by reference). Commissioner Goldman motioned to accept a Resolution in Title declaring two turnout jackets and two turnout pants (per the list attached to the original minutes) have exceeded their life span and are to be disposed of according to JTFD#4 practices, seconded by Commissioner Jamison. Motion passed by unanimous consent (Ayes: Couceiro, Goldman, Jamison; Nays: none; Absent: O'Brien, Torres; Abstain: None).

<u>Chief's Report</u>: read by Chief Trask O'Hara (a copy of which is attached to the original minutes and made a part thereof.)

<u>President's Report</u>: read by President Chelli (A copy of which is attached to the original minutes and made a part thereof). New applicant Kyle Martin was introduced to the Board.

Fire Bureau Report: read by Commissioner Couceiro (Fire Official O'Brien – absent). A copy of which is attached to the original minutes and made a part hereof.

Work Order Requests: addressed in Career Staff Report.

Old Business:

Projector Screen Project: Chief O'Hara reviewed the proposal submitted by Daniel Governale GC, LLC.

Screen: Commissioner Jamison motioned to purchase the screen at a cost of \$2,646 from Projector Screen.com (a copy of the proposal is attached to the original minutes), seconded by Commissioner Goldman. Motion carried by unanimous consent.

Projector Screen Installation and electrical scope: Commissioner Jamison motioned to accept the proposal in the amount of \$5,225.00 from Daniel Governale GC, LLC (a copy of the proposal is attached to the original minutes) to install the projector screen and electrical scope, seconded by Commissioner Goldman, pending approval of Board Attorney Braslow. Motion passed by unanimous consent.

Affidavit of Publication: Board Attorney Braslow will "cc" the Board anything that he sends out on behalf of the Board. Board Attorney Braslow will also Not request an affidavit of Publication unless law requires one. Board was in agreement.

New Business:

District #3 Class A Engines: Commissioner Jamison advised the Board that there was a proposal for the Board to purchase two (2) of Station #55's engines. Engines were reviewed by a mechanic and it was determined that they would be a "cash cow." Board was/is willing to expend up to \$20,000. Mechanic advised that there are vendors who have better engines available. Commissioner Jamison asked Board Attorney Braslow if a district to district sale can be done without going out to bid – Answer by Board Attorney Braslow: Yes, but I would want more details as you get closer to making a decision. If you are purchasing from a vendor, it is an entirely different concept. An older vehicle has been found for \$20,000. Cheryl is able to sign off on it with her QPA certification, but there must be minimum of two (2) other quotes - per Board Gov.deals is also acceptable – buying from another public Attorney Braslow. entity. Board is not moving forward with the JTFD #3 trucks. Trask to forward truck information that he has to Board Attorney Braslow and what the district is looking for (Class A engine).

WE BBQ for You: Proposal and Occurrence Form Certificate Page is attached to the original minutes. Discussion – They have used the facility in the past with no issues. Board must be listed as an additionally insured. Board was in agreement that it will be reviewed every six (6) months with only one person at a time using the facility. Commissioner Jamison motioned to accept the proposal subject to aforementioned conditions being met and counsel

approval of all documents, seconded by Commissioner Goldman. Motion passed by unanimous consent.

Supplies to be purchased:

Masks: Captain Leonard will have price quotes for the next meeting

SCBA: Price quoted in report was for direct replacement only - no spares

Fire Hose: Captain Leonard spoke with Ken Hollander/Continental (state contract). Prices are only going up. Board Attorney Braslow suggested to look at co-ops for competitive pricing. Commissioner Jamison suggested reaching out to other companies if they need hose to purchase jointly.

Tabled: Supply items are to be finalized for discussion at May 2022 meeting.

#5408 – Commissioner Jamison went down to Peterbilt and looked at the new tractor that arrived. Three items were different as per specs. Tires need to be replaced, fenders, bar across back for lights, these items will be replaced. Peterebilt is amenable to take care of everything.

Board Attorney Braslow left the meeting at 6:56 pm.

Three pagers still outstanding: Captain Leonard to check with Commissioner Torres on status of draft letter to those who have pagers. If draft is not done, Commissioner Jamison directed Captain Leonard to do it. Letters to be send out via US Mail – Regular and Certified Mail, Return Receipt Requested.

Bid Specs for replacement Generator at Station #2: After discussion, Commissioner Jamison motioned to have the bid specs for a replacement generator at Station #2 to be prepared, seconded by Commissioner Goldman. Motion passed by unanimous consent.

Letter from FF Ken Esposito: Request to use an engine for Fire Safety display on May 19, 2022 (a copy of the letter is attached to the original minutes). Board was in agreement.

<u>Adjournment</u>: With no other business to come before the Board, Commissioner Goldman motioned to adjourn the meeting, seconded by Commissioner Jamison. Meeting was adjourned at 7:03 p.m. by Commissioner Couceiro.
