Fire Commissioner Bollentin asked for a moment of silence.

Fire Commissioner Bollentin presented Fire Commissioner Goldman with his badge. Commissioner Torres entered the meeting at 8:05 p.m.

Motion passed by unanimous consent. Resolution was presented to Firefighter David Sisnetsky. Audit Resolution and Group Affidavit: Board Attorney Youssouf reported that the audit for 2014 was a "clean audit". Commissioner Torres motioned to accept the Resolution accepting the audit report for the year ending December 31, 2014, seconded by Commissioner Leonard. Motion passed by unanimous consent. Attorney Youssouf reviewed a recent court ruling regarding a dispute between a fire district and a town.

Truck & Building/Career Report – was presented by Commissioner Goldman. # 5410: questions on the oil change; #5444: truck still had to be jumped - all are asked to start it every couple of days; # 5411: cost of PTO replacement -Commissioner Ruditsky motioned to approve a rebuilt PTO, seconded by Commissioner Torres. Motion passed by unanimous consent; #5419: minor accident occurred, all taken care of; #5401: request to purchase mud flaps -Commissioner Leonard motioned to approve the purchase of mud flaps for #5401 at a cost not to exceed \$450, seconded by Commissioner Torres. Motion passed by unanimous consent. F/F Leonard brought up the leaks in the roof there are two cracks (33 feet and 10 feet) in roof. The area warranty rep is to come and inspect/analyze; 12 to 14 vents not installed across the front and down the side - work not done by Coffey Brothers.
