Minutes of Meeting Held June 11, 2015

Notice of the time, date, location and agenda of this meeting to the extent then known, was duly published at least forty-eight hours in advance of this meeting, by posting on the official bulletin board and by publications in the official newspapers of the Board. This meeting is being conducted in accordance with the terms and provisions of the "Open Meetings Act" of the State of New Jersey

<u>Call to Order-</u> The meeting was called to order by Chairman Jack Bollentin at 8:00 pm. "Open Meetings Act" statement was read by Board Attorney Youssouf. Commissioners Bollentin, Goldman, Leonard, and Ruditsky were present. Commissioner Torres was absent. Board Attorney Youssouf was also present. All participated in the Pledge of Allegiance. A moment of silence was observed.

<u>Minutes</u> – Commissioner Ruditsky motioned to approve the minutes of the May 14, 2015 General meeting with one correction (Under President's report, page 2, change name of "Jack Lubertazzi" to "Zack Lubertazzi", seconded by Commissioner Leonard. Motion passed by unanimous consent.

<u>Treasurer's Report</u> –The report and bill list (a copy of which is attached to the original minutes and incorporated herein by reference) as of June 11, 2015 was read by Commissioner Ruditsky. After discussion it was decided to withhold the check to the Jackson Township Municipal Authority in the amount of \$875 (due to no advance notice of increase for Board's budgeting purposes). Commissioner Leonard motioned to pay the bills as presented with the JT MUA check in the amount of \$875 being withheld, and to include payment to Susan L. Oksen-Pereira in the amount of \$225, seconded by Commissioner Goldman. Motion passed by unanimous consent.

<u>Legal Report</u>-Board Attorney Youssouf reported a NJ legislator is scheduled to speak at the convention. Discussion regarding pending legislature regarding the water company and the water company rates. Fire Department is to be exempt from water rate increases due to stand-by status.

Truck & Building/Career Department Report — read by Commissioner Goldman (a copy of which is attached to the original minutes and incorporated herein by reference). # 5401 — Lt. Reynolds requested that the rear step on pump out be extended further. #5411 — Commissioner Ruditsky motioned to approve the proposal from Blaze in the amount of \$1,750 to replace front suction pipe and to repair broken mounting bracket, seconded by Commissioner Goldman (a copy of the proposal is attached to the original minutes and incorporated herein by reference). Motion passed by unanimous consent. Proposals for repair to #03 right front and right rear were reviewed (a copy of the proposals is attached to the original minutes and incorporated herein by reference). After discussion, Commissioner Ruditsky motioned to accept the

proposal from Tilton in the amount of \$779, seconded by Commissioner Leonard. Motioned passed by unanimous consent.

Chief's Report— Chief Lubertazzi submitted a written report to the Board (a copy of the report is attached to the original minutes and incorporated herein by reference). Charger list was attached to Chief's report and discussed. Chargers to be kept in the Chief's truck(s). Commissioner Ruditsky motioned to spend up to \$200 for chargers, seconded by Commissioner Leonard. Motion passed by unanimous consent. Commissioner Bollentin advised the Chief that a spotter is to be used when backing up when backing up a vehicle that is insured by the Board of Fire Commissioners (for everyone — career and volunteer). Career staff is to advise when they go out of district so the company is aware of the situation. #05 is to go out on all rescues. # 17 is to go out on all EMS calls if feasible. All Board members were in agreement.

<u>President's Report</u> – No report. Quarterly report to the Board should be ready to be submitted to the Board for next month. It was reported that the bar is almost finished.

<u>Fire Bureau</u>: Report (part of the aforementioned Career Department Report) read earlier in the meeting by Commissioner Goldman.

<u>Work Orders</u>: Rim on #08 is damaged. Walk the truck before you drive it. If you see anything, report it.

Old Business/Correspondence: Correspondence: None

Old Business: Three proposals were received for shrub removal/paver installation at entranceway to hall (copies of each are attached to the original minutes and incorporated herein by reference). Commissioner Leonard motioned to accept the proposal from Good Mowin' for paver work. There was no second on the motion. FF Leonard to obtain prices on stamped concrete vs. pavers. Traffic Safety regarding changing the access to the station for response to fire calls: called Commissioner Bollentin tonight. JT Traffic Safety recommended a letter be sent to Jack Kelly/ OC Road Department. Letter to include response time. Information to be provided to Board Attorney Youssouf so that he may draft the letter. Commissioner Bollentin to have Traffic Safety call Board Attorney Youssouf to review the issues to be included. Three seal coating bids were received (copies of each proposal are attached to the original minutes and incorporated herein by reference). Commissioner Ruditsky motioned to accept the proposal from P&S Paving & Sealcoating pending inspection of three completed jobs by the contractor, seconded by Commissioner Leonard. Motion passed by unanimous consent. FF Leonard reported that the east coast supervisor rep for Tremco is scheduled to be here on June 17, 2015 to inspect. Commissioner Bollentin reported that they met with the architect last week to review plans for Station #2. The architect is going to come back with rough drawing.

<u>New Business</u>: Commissioner Leonard motioned to spend \$100 to have lettering done on the boat, seconded by Commissioner Goldman. Motion passed by unanimous consent.

<u>Executive Session</u>: Commissioner Ruditsky motioned to accept the Resolution to take the Board into an executive session for the purpose of discussing lawyer/client privileged material and personnel matters, seconded by Commissioner Leonard. Motion passed by unanimous consent at 9:01 p.m. Subject matter to be released when it is no longer privileged. The executive session ended at 9:35 p.m. and the Board reconvened the public session.

<u>Public Session</u>: Problems with the video recorder were discussed including the soda machine broken in to. Commissioner Ruditsky motioned to upgrade the video recorder per the proposal from Save & Secure Security System, LLC (a copy of the proposal is attached to the original minutes and incorporated herein by reference) at a cost not to exceed \$5,300, seconded by Commissioner Goldman. Motion passed by unanimous consent. Commissioner Ruditsky motioned to accept the Resolution in Title to schedule a special meeting on Monday, June 15, 2015 at 6:30 pm at Station #1, seconded by Commissioner Goldman. Motion passed by unanimous consent.

<u>Adjournment</u>: With no other business to come before the Board, Commissioner Ruditsky motioned to accept the Resolution to adjourn the meeting, seconded by Commissioner Goldman. Motion passed by unanimous consent. Meeting adjourned at 9:38p.m.
