Minutes of Meeting Held August 13, 2015

Notice of the time, date, location and agenda of this meeting to the extent then known, was duly published at least forty-eight hours in advance of this meeting, by posting on the official bulletin board and by publications in the official newspapers of the Board. This meeting is being conducted in accordance with the terms and provisions of the "Open Meetings Act" of the State of New Jersey

Call to Order- The meeting was called to order by Chairman Jack Bollentin at 8:02 pm. "Open Meetings Act" statement was read by Board Attorney Youssouf. Commissioners Bollentin, Goldman, and Leonard were present. Commissioners Torres and Ruditsky were absent Board Attorney Youssouf was also present. Board Attorney Youssouf declared that there was a quorum. All participated in the Pledge of Allegiance. A moment of silence was observed.

<u>Minutes</u>— Commissioner Leonard motioned to approve the minutes of the July 9, 2015 General meeting as presented, seconded by Commissioner Goldman. Motion passed by unanimous consent.

Treasurer's Report — The report and bill list (a copy of which is attached to the original minutes and incorporated herein by reference) as of August 13, 2015 was read by Commissioner Goldman. Check to Susan L. Oksen-Pereira in the amount of \$225 was omitted from the bill list and then added to the list. New total amount for bills paid August 13, 2015 is now \$42,295.86 Commissioner Leonard motioned to pay the bills as amended, seconded by Commissioner Goldman. Motion passed by unanimous consent. Commissioner Leonard motioned to accept the Treasurer's Report, seconded by Commissioner Goldman. Motion passed by unanimous consent.

<u>Legal Report</u>—Board Attorney Youssouf distributed to the Board members a Resolution that was passed at the July 9, 2015 meeting in Title appointing Cheryl Parker qualified Purchasing agent for the Board of Fire Commissioners for 2015. Resolution to be attached to July 9,2015 minutes.

Truck & Building/Career Department Report — read by Commissioner Bollentin (a copy of which is attached to the original minutes and incorporated herein by reference). FF Leonard reported that TREMCO has approximately 50 warranty repairs on the roof to do. TREMCO will honor the warranty, Coffey Bros. has been contacted by them and there has been no response from Coffey Bros.

Chief's Report— Chief Lubertazzi verbally reported: National Night out went well; vehicle was stabilized in 19 minutes; Water Rescue: course to be held at Station #1 on September 28, 2015 (Water Rescue Awareness — Flood Water & Lakes); requested that career fire fighters attend this course; reported that Nick Richardson was approved by the company as a junior member and was

introduced to the Board. Commissioner Goldman read item #1 from Commissioner Ruditsky's list (Chief's certificates from Baltimore). Chief advised the Board that certificates were not distributed at Baltimore. He has not yet been notified of the website address to print out certificates. As soon as he can access the website, he will print them out. Discussion followed regarding the issue between Chief and Commissioner Ruditsky with the chief asking for the Board's support. Commissioner Goldman motioned to accept Chief's report, seconded by Commissioner Leonard. Motion passed by unanimous consent.

President's Report - Not present - no report.

<u>Fire Bureau</u>: Report (part of the aforementioned Career Department Report) read by Fire Official Burmeister.

Work Orders: Commissioner Bollentin asked if the blade was changed. Firefighter Leonard reported that it had been and that items that "wear out" are kept in stock; Gas Cards: Fleet cards are charging a fee now. WEX gas cards are universal (accepted at Wawa, Hess, etc.) Commissioner Leonard motioned to open a new account for utilization of gas purchases, seconded by Commissioner Goldman. Motion passed by unanimous consent.

Old Business/Correspondence: Correspondence:

Old Business:

Architect: Board Attorney Youssouf recommends that the district hire an architect and that the design be based by maximum budget limitations. Discussion: Board to determine the amount to spend and what the community can afford. Commissioner Goldman motioned to approve a Resolution to hold a workshop session (open session to discuss Station #2) on Tuesday, August 18, 2015 at 7:30 pm, seconded by Commissioner Leonard. Motion passed by unanimous consent. Board Attorney Youssouf to publish meeting notification. Standard Operating Guidelines report: Commissioner Leonard presented his review of the SOG's submitted by Commissioner Ruditsky dated June 11, 2015 (a copy of the review is attached to the original minutes and incorporated herein by reference). Commissioner Leonard's summary opinion was that the responsibility of the Board is to oversee the proper housing and maintenance of the equipment. Chief is welcome to discuss movement of apparatus with commissioners when the need arises. Board Attorney Youssouf also advised the Board that it is inappropriate for commissioners to interfere with firematic activities as they are elected officials charged with budgetary operations, not firematic operations. There is a lack of legal authority to do that. Commissioner Bollentin directed that Cheryl type up a report that will be discussed with the Board at the next Board meeting.

New Business:

Commissioner Ruditsky submitted a list to be discussed at the Board meeting (a copy of which is attached to the original minutes and incorporated herein by reference). #1, #2 & #4 previously discussed. #3: Prior approval of all purchases. Discussion of "planned purchases" vs. "unplanned purchases". Board was in agreement that the current system (under \$ 1,000) is working and

to leave it unchanged. #5: After discussion, Commissioner Goldman motioned to approve \$1400 to be expended out of the fire company's fire prevention budget to cover the cost of open house T-shirts, seconded by Commissioner Leonard. Motion passed by unanimous consent.

Cascade System @ Station #2: after discussion of its non-use for many years, Firefighter Leonard to do some research on its value and other options that may be available to the Board and report at the next meeting.

Air Duct Cleaning: Commissioner Bollentin would like to have a company come in and clean out the air ducts – has never been done since the building has been built. Commissioner Goldman motioned to authorize the procurement of quotes for air duct cleaning at Station #1, seconded by Commissioner Leonard. Motion passed by unanimous consent. Cheryl directed to obtain quotes.

Commissioner Bollentin thanked the career staff and volunteers for all their work on the parking lot and National Night Out.

List of Physicals – List is being given to the Vice President. List is posted. Dents on 2011 Tahoe: After discussion, Commissioner Goldman motioned to have The Ding King repair the dents on the 2011 Chevy Tahoe, not to exceed \$500, seconded by Commissioner Leonard. Motion passed by unanimous consent.

Striping on Truck: Commissioner Goldman motioned to approve Venom Lettering, seconded by Commissioner Goldman, not to exceed \$1,250.00. Motion passed by unanimous consent.

Pete Kilgour: Commissioner Bollentin did speak to him a second time, advised him that he could appeal the Board's decision by writing a letter to the Board and Commissioner Bollentin offered him counseling. Cheryl confirmed that there has been no written communication from **M**r. Kilgour.

Adjournment: With no other business to come before the Board, Commissioner Goldman motioned to accept the Resolution to adjourn the meeting, seconded by Commissioner Leonard. Motion passed by unanimous consent. Meeting adjourned at 9:15 pm.
